SUBJECT: 2022 Lawn Mowing Services

REQUEST:

City Council is requested to authorize the issuance of a contract / blanket purchase order to Green Meadows Lawnscape, Inc. for 2022 Lawn Mowing Services for City-owned properties, Shoulder Right of Ways, Pathways, and Ordinance Compliance for Occupied & Vacant Lots sites in the amount not-to-exceed \$190,655 through December 31, 2022.

REASON FOR PURCHASE:

City owned properties, boulevards and neighborhoods are a highly visible component of the suburban landscape. It is important for the City to maintain the quality of its outdoor environment and natural features for the benefit of its citizens and to further enhance property values. The general appearance of these properties requires a level of maintenance for the proper landscape environment in order to preserve the citizens' investment in these properties.

The shoulder right of ways and pathways lawn mowing is essential to ensure the safety of pedestrians and motorists. These areas require specialized equipment and expertise of a lawn maintenance contractor in order to maintain adequate site distance along roadways. The services are essential as failure to maintain mowing operations is unsafe and unsanitary and constitutes a nuisance under City Ordinances as it may lead to rodent harborage, creation of sight distance issues, excessive clogging of storm water systems, flooding, etc.

The Purchasing Division solicited competitively sealed proposals for 2020 Lawn Mowing Services. Green Meadows Lawnscape, Inc. was selected as providing the best value and submitting the most responsive, responsible proposal for lawn mowing services. Green Meadows Lawnscape, Inc. has performed the noted services in the past in a professional and satisfactory manner. The City of Rochester Hills wishes to exercise its option to renew for the 2022 season.
