REQUEST:

The Department of Public Service requests City Council to approve the Cost Participation Agreement between the City of Rochester Hills and the Road Commission for Oakland County (RCOC) for the utility relocation work for the future widening of Tienken Road from Livernois Road to Sheldon Road; and authorize the Mayor and Clerk to execute the agreement on behalf of the City.

Final utility relocation costs will be billed to actual costs. Any utility relocation costs above the estimated amounts are required to be funded equally by the RCOC and City of Rochester Hills.

REASON FOR PURCHASE:

As part of the City's 2008 Master Thoroughfare Plan Update, the preferred alternative identified the Tienken Road corridor as a three (3) lane road section. During the Environmental Assessment (EA) phase of the Tienken Road Improvement project, the recommended alternative calls for a three (3) lane road section between Livernois and Sheldon with a dual-lane roundabout replacing the existing signalized intersection at Livernois and Tienken.

The RCOC in cooperation with the Michigan Department of Transportation (MDOT) have programmed and entered into a contract for the utility relocation work for the future widening of Tienken Road from Livernois Road to Sheldon Road. The utility relocation costs are estimated to be \$1,500,000. After federal funds in the amount of \$1,200,000 the local match estimated to be \$300,000 will be shared equally between RCOC and the City of Rochester Hills.
