SUBJECT: Purchase Authorization for Two (2) Hydraulic Valve Exercisers

REQUEST:

City Council is requested to authorize the purchase of two (2) Hydraulic Valve Exercisers from Tom H. Lewis Inc., dba Lewis Municipal Sales, Lebanon, IN in the amount of \$55,800.00.

REASON FOR PURCHASE:

The City issued a Request for Proposals for a hydraulic valve exerciser including a trailer and data tracking system utilizing the MITN system. The solicitation was distributed to ninety five potential vendors. One proposal response was received. Tom H. Lewis Inc., dba Lewis Municipal Sales proposed a Hurco Spin Doctor 800. The response was reviewed by the Department of Public Services Water and Sewer Department. The City has had two Hurco Spin Doctor valve exercisers and the department has been satisfied with the design, flexibility and ease of use of the equipment. The Hurco is also very compatible with the City's existing GIS system.

The hydraulic valve exercisers will be used to rotate water system valves on a regular basis to avoid costly repairs or replacement of the valves. The exercisers eliminate worker fatigue and injury while allowing multiple valves to be rotated on a daily basis. This routine maintenance of the City's valves ensure they are accessible and functioning for any future shutdowns. There are approximately 4,000 gate valves throughout the City's water system. These valve exercisers will replace the existing exercisers purchased in 2009 and 2010.

Award is recommended to Tom H. Lewis Inc., dba Lewis Municipal Sales as both a responsive responsible vendor meeting specifications.
