AN ORDINANCE TO AMEND SECTION 54-501 OF ARTICLE IX, OF CHAPTER 54, PEDDLERS, SOLICITORS AND ITINERANT MERCHANTS, OF THE CODE OF ORDINANCES OF THE CITY OF ROCHESTER HILLS, OAKLAND COUNTY, MICHIGAN, TO INCREASE THE PERMIT FEE FOR ITINERANT MERCHANTS; REPEAL CONFLICTING OR INCONSISTENT ORDINANCES, AND PRESCRIBE A PENALTY FOR VIOLATIONS.

THE CITY OF ROCHESTER HILLS ORDAINS:

<u>Section 1</u>. Section 54-501 of Article IX of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

Sec. 54-501. Itinerant merchants.

The permit fees for itinerant merchants, per individual, as provided in section 78-164, shall be \$25.0075.00. The annual license fee for ice cream vendors, as provided in section 78-171, shall be \$25.00, per vehicle.

<u>Section 2</u>. <u>Severability</u>. This ordinance and each article, section, subsection, paragraph, subparagraph, part, provision, sentence, word and portion thereof are hereby declared to be severable, and if they or any of them are declared to be invalid or unenforceable for any reason by a court of competent jurisdiction, it is hereby provided that the remainder of this ordinance shall not be affected thereby.

<u>Section 3</u>. <u>Penalty</u>. All violations of this ordinance shall be misdemeanors and upon conviction thereof shall be punishable by a sentence of not more than ninety (90) days of confinement to jail or by a fine of not more than \$500, or both, in the court's discretion.
