

COST PARTICIPATION AGREEMENT

(Windridge Blvd. to Bloomer Ridge)
Construction and Construction Engineering Services

This Agreement is entered into on _____, 2014, between the City of Rochester Hills, a Michigan municipal corporation, of 1000 Rochester Hills Drive, Rochester Hills, Michigan 48309 and the City of Rochester, a Michigan municipal corporation, of 400 Sixth Street, Rochester, Michigan, 48307.

WHEREAS, the two (2) Cities desire to make road improvements to Bloomer Road, between Windridge Blvd. to Bloomer Ridge. The project scope entails replacing the existing gravel road with 9-inches of asphalt pavement, 22-foot wide travel lane, with a 2-foot curb on the Rochester side and a 3-foot paved shoulder on the Rochester Hills side, totaling 27 feet. The pavement section will be over a minimum of 4-inches of aggregate base. Edge drain will be placed along the entire length; and

WHEREAS, upon completion, this project will upgrade and improve the section of roadway between the existing industrial subdivision on South Street and John R Road to meet Class A, all season standards; and

WHEREAS, through this Agreement, the City of Rochester Hills and City of Rochester desire to commit their oral understanding to writing concerning how the Construction and Construction Engineering Services costs will be apportioned.

THEREFORE,

1. Anderson, Eckstein and Westrick, Inc. , 51301 Schoenherr Road, Shelby Township, Michigan 48315 proposed to furnish the following services:

- Topographical Survey (DE) Fee

- Design and Bidding assistance (DE) Fee
- Right-of- Way Document preparation (DE) Hourly Basis
- Construction Staking (CE) Fee
- Contract Administration (CE) Fee
- Construction Observation (CE) Hourly Basis
- Record Plan information (CE) Fee

The Rochester Hills portion of the estimated Construction Costs are \$101,181.14 with forty percent (40%) of a ten percent (10%) contingency in the amount of \$10,156.00 totaling \$111,337.14

2. The City of Rochester will pay Anderson, Eckstein and Westrick, Inc. for one hundred percent (100%) of the actual costs associated with the Construction and Construction Engineering; and invoice the City of Rochester Hills for \$124,917.14. The City of Rochester Hills shall pay the invoice within thirty (30) days of receipt of same.

3. Any cost overages will be funded based on the Phase of the project and the Split percentage as noted in Section 1.
