REQUEST:

City Council is requested to authorize the purchase of one (1) Trackless Municipal Tractor MT7 and Attachments in the amount of \$173,508.00 from Bell Equipment, Lake Orion, Michigan utilizing the State of Michigan MiDeal Extended Purchasing Program.

REASON FOR PURCHASE:

The discount received by utilizing the State of Michigan contract for construction equipment is 5% off MSRP for the Trackless vehicles and attachments. The City's market research confirms this discount is consistent with other national contracts for the Trackless vehicles and best value to the City.

This municipal tractor will be used for sweeping operation in the summer, and snow clearing in the winter. It is especially useful for the Auburn Rd corridor and clearing pathways where this machine saves time, damage to our pickup trucks, safer operating conditions, and better visibility for our operators. These machines are built specifically for the rigors of this type of work, we have had a previous generation Trackless that has proven to be very rugged and reliable. With the addition of a snow blower attachment it will allow us to more efficiently clear snow and also give the ability to easily load trucks when snow needs to be hauled away.
