SUBJECT: Green Space and Natural Features Stewardship Program Services

REQUEST:

City Council is requested to authorize a blanket purchase order/contract to Stantec Consulting Services, Inc., Chicago, Illinois for Green Space and Natural Features Stewardship Program Services in the amount not-to-exceed \$540,000.00 through December 31, 2024.

REASON FOR PURCHASE:

Request for Proposals were solicited utilizing the MITN system in 2019 and award was issued to Cardno, Inc. The contract called for a three (3) year contract term with one (1) 2-year renewal option. The City wishes to exercise the renewal option. In December 2021, Stantec Consulting Services, Inc. (Stantec) purchased Cardno, Inc. Stantec will maintain the Cardno Group's present office locations with no interruption in operations or client services, and all future projects and operations will be transitioned to the Stantec name effective January 1, 2023. An assignment letter has been executed and is on file. Stantec has agreed to hold pricing and extend the contract for an additional two (2) year period.

Three proposal responses were received and reviewed by a committee consisting of Parks and Natural Resources staff, as well as a Green Space Advisory Board member. Two (2) firms were shortlisted and interviews were conducted. Cardno, Inc., was selected as providing the best value to the City based on their experience, qualifications, service offerings and best value cost proposal. Cardno, Inc. is being recommended for award based on the above factors as well as providing some additional value added services as part of their partnership with the City, and includes things such as participation in Green Space events, educational outreach campaigns (website information, etc.), and grant assistance.

In 2013, Rochester Hills voters approved a ballot proposal to revise the permissible use of tax revenues derived from the Green Space Millage to be used to fund the protection, care and maintenance of, and to improve pedestrian accessibility to and within, green spaces and natural features owned, acquired or controlled by the City, in addition to funding the purchase of land and interests in land. Natural Features Stewardship program services began in 2014 and have continued over the past 5 years where the city has continued to perform management of our green spaces and natural features on city owned-properties.

These services continue to be needed in the city to complete and continue several projects and efforts, including invasive species management, native vegetation plantings, habitat restoration, and natural features preservation.
