CORRECTED (FOR CURRENT ZONING DESIGNATION) NOTICE OF PUBLIC HEARING FOR PRELIMINARY ONE FAMILY RESIDENTIAL DETACHED CONDOMINIUM PLAN and REQUEST FOR TREE REMOVAL PERMIT <u>PLANNING COMMISSION</u>

TO ROCHESTER HILLS RESIDENTS:

NOTICE IS HEREBY GIVEN THAT THE CITY OF ROCHESTER HILLS PLANNING COMMISSION will conduct a Public Hearing In accordance with the Michigan Zoning Enabling Act, Public Act 110 of 2006, as amended; the Land Division Act, Public Act 288 of 1967, as amended, and Chapter 122 Article IV of the Code of Ordinances of the City of Rochester Hills, a Public Hearing for a Preliminary One Family Residential Detached Condominium Plan Recommendation is required for review which requires the Rochester Hills Planning Commission to conduct a Public Hearing before making a recommendation to the City Council.

Pursuant to the Tree Conservation Ordinance, Chapter 126, Article III, of the Code of Ordinances of the City of Rochester Hills, Oakland County, Michigan, this notice shall also serve as a minimum of seven days' notice to all adjacent property owners regarding the request for a Tree Removal Permit as described below.

LOCATION: North side of Walton Blvd., between Adams and Firewood Dr., Parcel No. 15-07-376-038, zoned R R-2 One Family Residential (Project No. JSC2022-0002)

REQUEST: Preliminary One Family Residential Detached Condominium Plan Recommendation. The proposal is for the Walton Oaks Condominiums, a proposed eleven (11) unit, detached single-family development on approximately 6.8 acres of land.

REQUEST: Tree Removal Permit. A request to remove one hundred sixty-seven (167) regulated trees and thirty nine (39) specimen trees and provide two hundred sixty-two (262) replacement trees.
