

**INTERLOCAL SERVICE AGREEMENT**  
**BETWEEN CITY OF ROCHESTER HILLS**  
**AND**  
**CHARTER TOWNSHIP OF WASHINGTON**  
**FOR PUBLIC WORKS AND FLEET SERVICES**

**RECITALS**

WHEREAS, the City of Rochester Hills, a Michigan municipal corporation, 1000 Rochester Hills Drive, Rochester Hills, MI 48309 (hereinafter "ROCHESTER HILLS"), and the Charter Township of Washington, a Michigan municipal corporation, 57900 Van Dyke., Washington, MI 48094 (hereinafter "WASHINGTON,"), together referred to as the "Parties" or the "Party" are authorized separately by law to provide fire, emergency medical and public works services, (hereafter referred to collectively as "Public Works and Fleet Services") for their respective public entities; and

WHEREAS, the Michigan Constitution of 1963, Article 7, §28, and the Urban Cooperation Act of 1967, being MCL 124.501, et. seq. (the "Act"), permit a political subdivision to exercise jointly with any other political subdivision any power, privilege or authority which such political subdivisions share in common with which each might exercise separately; and

WHEREAS, due to the fact that some areas of municipal services need to meet specific standards or details which require specialized skills and knowledge, and it is difficult for public entities to locate service providers that are able to perform those specialized services, economically, properly and timely; and

WHEREAS, ROCHESTER HILLS has specific areas of expertise in its Public Services and Fleet Divisions and has the facilities and personnel capable to perform Public Works and Fleet Services for WASHINGTON; and

WHEREAS, ROCHESTER HILLS represent and acknowledge that it has the necessary facilities, tools, equipment and personnel to assist, repair and provide Public Works and Fleet Services for WASHINGTON; and

WHEREAS, the Parties mutually desire to enter into this Agreement to allow ROCHESTER HILLS to provide Public Works and Fleet Services to WASHINGTON on an as-requested basis; and

WHEREAS, pursuant to resolutions adopted by their respective City Council and Township Board, the Parties each have been authorized to execute this Agreement for ROCHESTER HILLS to provide Public Works and Fleet Services for WASHINGTON on an as-requested basis according to the terms and conditions set forth below.

THEREFORE, the Parties agree, as follows:

1. WASHINGTON engages ROCHESTER HILLS' Public Services and Fleet Divisions to provide Public Works and Fleet Services consisting of the following: service and/or maintenance on fire and emergency medical vehicles and equipment; water and/or sewer system vehicles and equipment; and other Fire/Emergency Medical or Public Works Services as requested. ROCHESTER HILLS will arrange to have a contact person on call, if needed, 24 hours a day, 7 days per week. WASHINGTON understands and acknowledges ROCHESTER HILLS first priority is to service its own municipality. However ROCHESTER HILLS will make every reasonable effort to timely complete work for WASHINGTON.
2. ROCHESTER HILLS will perform Public Works and Fleet Services in accordance with accepted industry standards and practices.
3. Subject to an annual adjustment of rates as provided in Paragraph 5, WASHINGTON shall pay ROCHESTER HILLS for the services provided as follows:
  - A. During Regular Business Hours (M-F, 7:00am – 3:30pm):

Technician's time: \$87.30 per hour or  $\frac{1}{4}$  fraction thereof until 4/30/2016.

Vehicle/Equipment hourly rate: According to MDOT's current Act 51 Rates/hour or  $\frac{1}{4}$  hour fraction for the duration of the agreement.
  - B. During Weekends, Holidays and after Regular Business Hours:

Technician's premium time: \$130.95 per hour or  $\frac{1}{4}$  fraction thereof until 4/30/2016.

For services performed after or before regular business hours, or on weekends or holidays, Public Works and Fleet Services will be billed at premium rate (time and a half or double time) with a minimum billing of four (4) hours of service.
4. WASHINGTON shall also pay the costs for all parts, materials and supplies used. An administrative fee of 20% for parts costing under \$100, 5% for parts over \$100 will be assessed on parts, oils and lubricants provided by ROCHESTER HILLS.

5. Before June 1<sup>st</sup> of each year, starting in 2016, ROCHESTER HILLS shall review its personnel costs and any costs affecting their ability to provide Public Works and Fleet Services under this Agreement. If those costs have increased, the Parties shall come to an agreement on the amount of and reason for the increased costs for services under the Agreement. Those increased costs will become effective for services provided after July 1st of each year. In the event a Party's collective bargaining agreement with its respective unit changes in the wages or benefits category, then the parties agree to meet and decide on a modified change.
6. ROCHESTER HILLS shall invoice WASHINGTON on a monthly basis for Public Works and Fleet Services, parts and materials provided during the preceding month. WASHINGTON shall pay ROCHESTER HILLS' invoices within thirty (30) days of the invoice date.
7. ROCHESTER HILLS reserves the right to, in its discretion, withhold or refuse to provide services to WASHINGTON. WASHINGTON is not obligated to use the services of ROCHESTER HILLS exclusively, and WASHINGTON is expressly allowed to obtain Public Works and Fleet Services through other means or vendors.
8. This Agreement does not, and is not intended to include or connote any warranties, promises or guarantees by ROCHESTER HILLS of any nature whatsoever, concerning the provision of Public Works and Fleet Services. SPECIFICALLY, NO WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR ANY OTHER WARRANTY IS MADE OR TO BE IMPLIED WITH RESPECT TO SERVICES, MATERIALS OR PARTS PROVIDED UNDER THIS AGREEMENT. IN NO EVENT SHALL ROCHESTER HILLS BE LIABLE FOR ANY INDIRECT, INCIDENTAL, PUNITIVE, EXEMPLARY OR CONSEQUENTIAL DAMAGES WHATSOEVER UNDER CONTRACT, TORT OR OTHERWISE.
9. The Agreement shall continue in effect until terminated by either Party. Either Party may terminate its participation in this Agreement, for any reason (including the convenience of the Party), without penalty. A Party may deliver a written notice of termination of the Agreement to the other Party in accordance with the notice provision of Paragraph 17. Termination shall become effective thirty (30) days from the date of the notice unless the terminating Party specifies a later termination date in the notice supplied to the other Party.
10. Upon receipt of notice of termination of the Agreement, ROCHESTER HILLS shall, within thirty (30) days, deliver a final invoice to WASHINGTON for any current charges and outstanding balances that have not previously been invoiced or paid. WASHINGTON shall continue to be responsible for payment for the cost of services, parts and supplies either invoiced prior to termination or performed or purchased by ROCHESTER HILLS before the notice of termination. ROCHESTER HILLS will attempt to return any new or used parts and supplies to suppliers that it is unable to use. If ROCHESTER HILLS is unable to obtain full refunds or only obtains partial refunds, WASHINGTON will be invoiced for those non-refundable and/or partially

refundable parts and supplies. WASHINGTON shall pay ROCHESTER HILLS invoice within thirty (30) days from the date of the invoice.

11. At all times and for all purposes under this Agreement, the Parties' relationship to each other is that of an independent contractor. No liability, right or benefit arising out of any employer/employee relationship, either express or implied, shall arise or accrue to any Party as a result of this Agreement.
12. All of the privileges and immunities from liability, and exemptions from laws, ordinances and rules, and all pensions, relief, disability, worker's compensation and other benefits which apply to the activity of officers, agency, or employees of any public agency when performing their respective functions within the territorial limits of their respective agencies shall apply to the same degree and extent to the performance of such functions, services and duties under this Agreement. Furthermore, the Parties believe that performance of services and duties pursuant to this Agreement will be in the exercise or discharge of a governmental function.
13. Notwithstanding the disclaimer of warranties and limitation of damages in paragraph 8 hereof, ROCHESTER HILLS shall indemnify, defend and hold harmless WASHINGTON from any and all claims of damage to WASHINGTON'S property or facilities proximately caused by the gross negligence of ROCHESTER HILLS in the provision of Public Works and Fleet Services under this Agreement. The duty to indemnify, defend and hold harmless shall include all costs of litigation or defense of claims including attorney fees, costs and expert fees.
14. ROCHESTER HILLS acknowledges that it is currently insured with proper coverage and limits. ROCHESTER HILLS agrees to keep its current insurance, or insurance of a similar nature, in effect at all times while providing Public Works and Fleet Services to WASHINGTON. Upon request, ROCHESTER HILLS shall provide a Certificate of Insurance as evidence of its coverage.
15. The Parties agree that they shall promptly deliver to the other Party written notice and copies of any claims, complaints, charges, or any other accusations or allegations of negligence or other wrongdoing, whether civil or criminal in nature, that the other Party becomes aware of which involves, in any way the facility, equipment, personnel and/or services under this Agreement. Unless otherwise provided by law and/or the Michigan Court Rules, the parties agree to cooperate with each other in any investigation conducted by another party of any acts or performances of any services under this Agreement.
16. The Parties agree that all indemnification, defense and hold harmless promises, waivers of liability, representations, insurance coverage obligations, liabilities, payment obligations and/or any other related obligations provided for in this Agreement with regard to any acts, occurrences, events, transactions, or claims, either occurring or having their basis in any events or transaction that occurred before termination of this Agreement, shall survive the termination.


17. Any written notice required or permitted under the Agreement shall be considered delivered to a party as of the date that such notice is deposited, with sufficient postage, with the U.S. Postal Service. Unless specifically otherwise set out in the Agreement, all notices sent to ROCHESTER HILLS shall be sent to Mayor, City of Rochester Hills, 1000 Rochester Hills Drive, Rochester Hills, MI 48309-3033. All notices sent to WASHINGTON shall be sent to SUPERVISOR, Charter Township of WASHINGTON, 57900 Van Dyke, Washington, MI 48094.
18. This Agreement sets forth the entire agreement between the Parties and supersedes any prior understandings or agreements. Amendment or modification of this Agreement shall be in writing signed, dated and approved by both Parties. The language of this Agreement shall be construed as a whole according to its fair meaning and not constructed strictly for or against any Party, as both Parties participated in the drafting of this Agreement. The Parties have taken all actions and secured all approvals necessary to authorize and complete this Agreement.
19. If a Court of competent jurisdiction finds any provision of this Agreement invalid or unenforceable, then that provision shall be deemed severed from the Agreement. The remainder of this Agreement shall remain in full force.
20. This Agreement is made and entered into in the State of Michigan and shall in all respects be interpreted, enforced and governed under the laws of the State of Michigan. Except as otherwise required by law or court rule, any action brought to enforce, interpret or decide any claim arising under this Agreement shall be brought in the Oakland County Circuit Court, the 52-3 District Court, or the United States District Court for the Eastern District of Michigan, Southern Division as dictated by the applicable jurisdiction of the court. Except as otherwise required by law or court rule, venue is proper in the courts set forth above.
21. The recitals shall be considered an integral part of the Agreement.
22. Except as expressly provided herein, this Agreement does not create, by implication or otherwise, any direct or indirect obligation, duty, promise, benefit, right of indemnification (i.e., contractual, legal, equitable, or by implication), right of subrogation as to any Party's rights in this Agreement, or any other right of any kind in favor of any third party beneficiary, individual or legal entity.
23. Each Party shall be responsible for obtaining and maintaining, throughout the term of this Agreement, all licenses, permits, certificates, and governmental authorizations for its employees and/or agents necessary to perform all of its obligations under this Agreement. Upon request, a Party shall furnish copies of any permit, license, certificate or governmental authorization to the requesting Party.
24. Absent a written waiver, no fact, failure or delay by a Party to pursue or enforce any rights or remedies under this Agreement shall constitute a waiver of those rights with regard to any existing or subsequent breach of this Agreement. No waiver of any term, condition, or provision of this Agreement, whether by conduct or

otherwise, in one or more instances shall be deemed or construed as a continuing waiver of any term, condition, or provision of this Agreement. No waiver by a Party shall subsequently affect its right to require strict performance of this Agreement.

IN WITNESS WHEREOF, this Agreement if executed by the Parties on the date hereafter set forth.

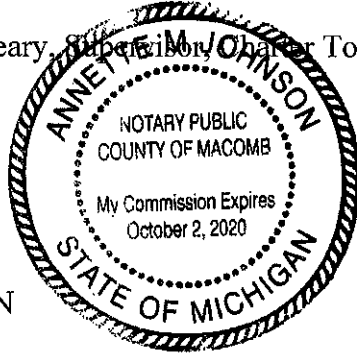
