SUBJECT: 2015 Pathway Program - City File No. E15-003

REQUEST:

City Council is requested to authorize a blanket purchase order/contract for the 2015 Pathway Program in the amount of \$69,073.62 with a 10% project contingency in the amount of \$6,907.36 for a total not-to-exceed amount of \$75,980.98 to Pavex Corporation, Trenton, MI and further authorizes the Mayor to execute the contracts on behalf of the City.

REASON FOR PURCHASE:

The City issued an Invitation to Bid for the 2015 Pathway program utilizing the MITN system. Two bid responses were received. Of the bid responses received Pavex Corporation was the lowest, responsive, responsible bidder.

The Department of Public Services staff will provide the following construction professional engineering services for this project: inspection, complaint resolution, and contract administration. Other costs associated with the project include geotechnical services (typically 2.5% of contractor payments) and survey & layout supplies such as stakes and paint.
