SUBJECT: Adams Road at Walton Boulevard DTE Street Light Agreement - City File No. E14-010

## **REQUEST:**

The Department of Public Services requests City Council to approve the Master Agreement for Municipal Street Lighting (Agreement) between the City of Rochester Hills and the Detroit Edison Company for the installation of street lighting at the Adams Road and Walton Boulevard Intersection. The Department of Public Services requests City Council to approve the Master Agreement for Municipal Street Lighting (Agreement) between the City of Rochester Hills and the Detroit Edison Company for the installation of street lighting at the Adams Road and Walton Boulevard intersection; and authorize the Mayor to execute the agreement on behalf of the City.

## **REASON FOR AGREEMENT:**

The proposed lighting includes five (5) 280 watt Autobahn cobra head LED's on existing wood poles at the intersection of Adams Road and Walton Boulevard. The proposed lighting photometric plan illuminates the four (4) quadrants of the boulevard intersection, including the pedestrian ramp crossings. The street lighting installation will be undertaken as part of the traffic signal upgrade project being undertaken by the Road Commission for Oakland County (RCOC).

The total street lighting installation cost is \$4,147.48, however, the Federal safety grant funding will be cover 80% of the street light and traffic signal installation costs with the remaining 20% being a local match covered by the Road Commission for Oakland County (RCOC). Thus, no share required by the City. The annual operations and maintenance costs will be incorporated into the City's monthly street light invoice.

The installation of the street lighting is contingent upon RCOC's traffic signal upgrade project, which is tentatively anticipated to commence in fall of 2015 or spring of 2016.

## **RECOMMENDATION:**

The Department of Public Services requests City Council to approve the Master Agreement for Municipal Street Lighting (Agreement) between the City of Rochester Hills and the Detroit Edison Company for the installation of street lighting at the Adams Road and Walton Boulevard intersection as part of the traffic signal upgrade project by RCOC; and authorize the Mayor to execute the agreement on behalf of the City.
