SUBJECT: Purchase Authorization for Crane Service Body

REQUEST:

City Council is requested to authorize the purchase of one (1) new crane service body from Knapheide Truck Equipment, Flint, Michigan in the not-to-exceed amount of \$30,697.81.

REASON FOR PURCHASE:

Quotes were solicited utilizing the MITN system for the purchase of one (1) new crane service body for the Department of Public Services hydrant vehicle. A total of eight quotes from six vendors were received. Knapheide Truck Equipment was the low responsive responsible quote.

This crane service body is a scheduled replacement for the DPS fire hydrant service truck. DPS purchased the truck cab and chassis earlier in 2015 through the Oakland County Cooperative Purchase Program. The larger and more functional crane will be multi-use, and provide for fire hydrant maintenance as well as removal and placement of the large sewage lift pumps at the City's lift stations, water main section and valve repair/replacement, and pump/valve maintenance at the City's water system booster pump stations. The smaller crane on the old truck did not have the capacity or reach for these tasks.
