SAD Paving Petitions Verification Report

Attached please find a copy of the Eyster's Avon Gardens, Norton Lawn street paving petitions, petition verification report and a map indication those parcels that have signed the petitions.

From the Norton Lawn total gross lineal front footage within the proposed district, 4,216.61 feet, we have verified signatures of owners of record on 2,970.70 lineal front feet. This calculates to 70.45% of the privately real property fronting the street to be paved. Of the 35 property descriptions that comprise the district, 24 (68.57%) have petition signatures.
