**SUBJECT:** Landscape Architectural Design Services for Riverbend Park Development

### **REQUEST:**

City Council is requested to authorize a blanket purchase order/contract to DesignTeam Plus, LLC., Birmingham, Michigan to provide Landscape Architectural Design Services for the development of Riverbend Park in the amount not-to-exceed \$60,000.00 and further authorizes the mayor to execute an agreement on behalf of the City.

## **REASON FOR PURCHASE:**

Requested design and construction drawing services are for the pond area from Phase II of the Riverbend Park Strategic Planning Framework. These services are necessary prior to starting development work on the pond area.

The City posted a Statement of Qualifications, utilizing the MITN system, in which twelve responses were received. Award recommendation was presented to City Council at its May 18, 2015 meeting for approval of a contract to DesignTeam Plus, LLC for Landscape Architectural Services, in which City Council approved. Design Team Plus, LLC., was selected based on their qualifications, familiarity with the project, and best qualified to work with the City on the project. DesignTeam Plus, LLC working in coordination with Hubbell, Roth & Clark, is qualified to provide the professional efforts required for the development of Riverbend Park meeting the goals and objectives of the City.

#### **BUDGET:**

As part of the 2016-18 Budget process, \$750,000 was allocated in the Facilities Fund for the development of Riverbend Park in FY 2016 (expense). As well an offsetting \$750,000 was identified in the Facilities Fund for Contributions and Donations related to the development of Riverbend Park in FY 2016 (offsetting revenue).

Note: City Council has previously approved a pending MDNR grant application with a total estimated project cost of \$300,000 [funded through a 50% MDNR grant in the amount of \$150,000 and a 50% City match of \$150,000].

If approved by City Council, it is recommended that the General Fund contribute \$60,000 to the Facilities Fund for this Riverbend Park service. As Riverbend Park is a "new" park, there are no accumulated funds within the Facilities Fund dedicated towards it.
