SUBJECT: 2021 Plant Health & Lawn Care Services

REQUEST:

City Council is requested to authorize the issuance of a contract / blanket purchase order to Owen Tree Service, Inc. of Attica, Michigan for 2021 Plant Health & Lawn Care for City-owned sites in the amount not-to-exceed Forty Thousand Five Hundred (\$40,500) Dollars through December 31, 2021.

REASON FOR PURCHASE:

City owned properties and boulevards are a highly visible component of the suburban landscape. It is important for the City to maintain the quality of its outdoor environment and natural features for the benefit of its citizens and to further enhance property values. The general appearance of these properties requires a level of maintenance for the proper care of the lawns, trees and shrubs in order to preserve the citizens' investment in these properties.

The City of Rochester Hills Purchasing Division solicited proposals utilizing the MITN system for plant health and lawn care services. Three proposal responses were received and evaluated by a committee consisting of staff from Facilities and Building departments. The proposal submitted by Owen Tree Service, Inc. of Attica, Michigan Inc. was selected as providing the best value proposed for fertilization, shrub & tree care and plant health.

Owen Tree Service has performed the noted services in the past in a professional and satisfactory manner.
