1.) <u>Define property inventory</u>: (Members Carvey, Gauthier, Hartner, Moore, Balusu)

Chairperson Carvey noted no report at this time.

2.) <u>Define stewardship for Rochester Hills and develop a mission statement:</u> (Members Tilove, Graves, Peterson, Dohr, Thorpe)

As noted in the February 26 and March 26, 2013 minutes, the Board consensus for the definition of stewardship was as follows: "Stewardship is the responsible managing of land to protect, conserve, and enhance biodiversity and natural features, for the benefit of current and future generations."

As noted in the April 23, 2013 minutes, the Board unanimously supported the mission statement as follows: "It is the mission of the Rochester Hills' Green Space Advisory Board to enhance our community through the preservation and stewardship of natural features."

Member Peterson presented a draft vision and value statement that could be used as a preamble when making a presentation to City Council to suggest expanding the use of the millage fund to include stewardship management.

Chairperson Carvey suggested that the presentation also include the idea of acquiring open space parcels outside the City's boundaries if any valuable parcels would become available.

Discussion included some pros and cons of acquiring open space parcels outside the boundaries of Rochester Hills as well as the importance of designing a solid presentation to City Council. Not only would it protect and preserve natural features and remove invasive species on the City's open spaces but could also enhance the Clinton River running through Rochester Hills, which is a premiere natural feature. A concern was noted regarding the expansion of GSAB's mission and that it could be construed as too big of a foot print.

The Board examined the original ballot language for the green space millage that was passed by voters in 2005. If City Council expands the mission of GSAB to include stewardship, then the voters would be asked to approve a ballot question that would repurpose existing green space funds to allow stewardship expenses. Residents would need to be convinced that it is in their best interest to allow the City to enact a stewardship management plan to protect the natural environment which would also enhance the economic value of their homes.

Members reviewed the draft vision and value points and made suggestions.

Member Peterson will incorporate the suggestions and present a revised draft at
