**SUBJECT:** Barclay Circle Road Rehabilitation from Rochester to Auburn

## **REQUEST:**

The Department of Public Services (DPS) requests that City Council authorize a blanket purchase order/contract for preliminary engineering services for the Barclay Circle rehabilitation project to OHM Advisors in a not-to-exceed amount of \$176,000.00 and further authorizes the Mayor to execute a contract on behalf of the City.

### **REASON FOR PURCHASE:**

Rochester Hills completed an update to the Master Transportation Plan in February 22, 2021 and one of the recommended projects was a road diet for Barclay Circle that could provide dedicated bike lanes. Barclay Circle currently has two thru-lanes in each direction and one center turn-lane. The proposed "road diet" would eliminate one thru-lane in each direction and utilize the repurposed width for bike lanes. In addition to the lane changes, a pavement mill and overlay would be performed to rehabilitate the existing pavement surface.

The Michigan Department of Transportation (MDOT) is currently planning to perform a traffic signal upgrade to the Rochester/Barclay intersection in 2025. It is desired to complete our realignment work ahead of the MDOT project so that the MDOT project can finalize their future design work based on our proposed roadway change.
