SUBJECT: Construction Engineering Services 2022 Concrete Road and Sidewalk Program

REQUEST:

City Council is requested to authorize a contract/blanket purchase order for Construction Engineering Services for the 2022 Concrete Road and Sidewalk Program to Spalding DeDecker, Rochester Hills, Michigan in the amount not-to-exceed \$313,465.00 and further authorizes the Mayor to execute an agreement on behalf of the City.

REASON FOR PURCHASE:

The Department of Public Services received bids for the 2022 Concrete Road and Sidewalk Program on March 8, 2022 with award of the project by City Council at their March 21, 2022 meeting. The department is now bringing forward a request for approval of construction engineering services to assist with the project. Based on the 2022 department workload, the Department of Public Services has determined an engineering consultant should be used for this project to supplement City staff with construction engineering services.

Staff is recommending Spalding DeDecker to provide the construction engineering services to the City. The attached proposal describes the scope of services included for the construction engineering services to complete the work. Spalding DeDecker is one of the City's selected on-call professional engineering firms and assisted in the design and specifications of this project.
