SUBJECT: 2015 Millage Rates

REQUEST:

In accordance with the City Charter Section 3.1 <u>Budget Procedure and General Finance</u>, Section 3.6 <u>Adoption of a Budget</u>, Section 4.1 <u>Power to Tax and Special Revenue</u>, and Section 4.2 <u>Charter Tax Rate</u> <u>& Special Voted Millage(s) Limitation</u> we are requesting that City Council approve the revised 2015 millage rates (to be levied in December 2015), which will provide the tax revenues needed to support the FY 2016 budget.

BACKGROUND:

On September 14, 2015 the Rochester Hills City Council approved millage rates proposed as part of the FY 2016-2018 Budget process with a combined total City millage rate of 10.3605. This rate included 0.0000 mills for OPC Transportation since the millage expired with the 2014 millage levy, which provided funding for FY 2015.

Pursuant to the requirements of the State Tax Commission, municipalities must file State form L-4029, tax rate request, with the Oakland County Department of Equalization by October 1, 2015. The City is also required to file form LT-1, Annual Report of Taxes, with Oakland County on or before October 1, 2015.

On November 3, 2015, the residents of Rochester Hills voted and approved a new OPC Transportation millage of up to 0.1000 mills. OPC has requested the full 0.1000 mill be included on the December, 2015 tax bill to provide funding for the 2016 fiscal year.

We are proposing City Council adopt and authorize the millage rates as listed below, which will allow Administration to file a <u>revised</u> State form L-4029, tax rate request, with the Oakland County Department of Equalization
