SUBJECT: Commercial, Industrial and Residential Plan Review Services

### **REQUEST:**

City Council is requested to authorize a contract/blanket purchase order for commercial, industrial and residential plan review services to International Energy Conservation Consultants, LLC, Tinley Park, IL in the amount not-to-exceed \$160,000.00 through December 31, 2025 and further authorizes the Mayor to execute an agreement on behalf of the City.

#### **REASON FOR PURCHASE:**

The City's Purchasing Division issued Request for Proposals for Building Plan Review Services utilizing the MITN website with four (4) proposal responses received. A committee consisting of staff from the City's Building Department reviewed the proposal responses and is recommending award of the contract to International Energy Conservation Consultants (IECC), LLC as best value firm based on their experience and qualifications, comparable projects, capacity, and overall best value cost proposal which proposed to align with the Building Departments current schedule of fees providing an easier to understand cost schedule when providing estimates to customers. IECC has performed work for the City in the past with Energy Plan Reviews and the City has been satisfied with the services received. IECC will be used to assist the Building Department with plan review services on an as-needed basis.
