SUBJECT: Construction Inspection Services

REQUEST:

City Council is requested to authorize a blanket purchase order for as needed construction inspection services to Spalding DeDecker Associates, Inc., Rochester Hills, Michigan in the amount not-to-exceed \$150,000.00 through December 31, 2016.

REASON FOR PURCHASE:

Due to the numerous public and private development projects proposed to be completed during the 2016 construction season, the Department of Public Services is requesting assistance from Spalding DeDecker Associates, Inc. to perform as needed construction inspection services.

Construction inspection services performed on private development projects are pass-through in nature, meaning that offsetting private developer escrow funds will be charged as revenues to offset the private inspection services expenditures. Construction inspection services may also be used for public projects, when deemed necessary due to staffing levels.

The requested blanket amount of \$150,000 is an estimate based on the public and private development projects that could be constructed this year and the hours associated with that work.
