SUBJECT: Norton Lawn & Hickory Lawn Special Assessment District (SAD) Paving Request

Construction Engineering Services, City File No. E14-030

REOUEST:

The City Council is requested to approve an construction engineering services contract with Orchard, Hiltz & McCliment, Inc. (OHM) for the proposed special assessment district paving of Norton Lawn and Hickory Lawn in a not-to-exceed amount of \$110,000.00.

REASON FOR PURCHASE:

The Department of Public Services recently had two resident-driven requests for the gravel road paving of Norton Lawn and Hickory Lawn. These two streets progressed through the various stages of the City SAD process during 2014 and 2015 and the proposed construction project was bid January 10, 2016. Based on the 2016 department workload, The Rochester Hills Department of Public Services has determined that the construction engineering services component of the project should be supplemented by an engineering consultant.

OHM prepared the design plans and specifications for the Norton Lawn/Hickory Lawn paving project and is recommended to provide the construction engineering services to the City. The attached OHM proposal describes the scope of services included for the construction engineering services to complete the work in greater detail.
