Dear Charitable Gaming Control Board representative,

The Motor City Baseball Club ("MCBC") is a non-profit 501(c)(3) organization that has been in existence since September of 2010. MCBC was organized exclusively for charitable and educational purposes to encourage and educate young people ages five through eighteen in youth baseball and provide an environment of competition and personal growth. Since inception, MCBC has involved over 100 Michigan youth in its development programs every year. Since we are starting our sixth year of operations, it is a significant number of young men our program has touched.

MCBC participates in various fundraising activities in an effort to further our purpose in the community. All funds raised directly offset the cost of running our programs. Currently, MCBC fundraising efforts are limited to sponsor donations and events. A parent recently informed the MCBC Board of a charity poker fundraiser that he participates in for a similar youth sports organization. Upon receipt of our license, we are planning to participate in a Vegas-style Millionaire Party at a local, licensed, organized and structured facility.

Attached is our application for a Millionaire's Party License together with all of the qualification documentation. The only item missing from the qualification requirements is the local government body resolution stating the organization is a recognized nonprofit in the community. We are currently working with the Rochester Hills City Clerk in an effort to obtain the resolution. Currently, all paperwork has been submitted to the City Clerk and MCBC's resolution is included on the upcoming City Council meeting agenda for October 26, 2015.
