**SUBJECT:** Increase to Blanket Purchase Order for Third Party Website Hosting

#### **REQUEST:**

City Council is requested to authorize an increase to the blanket purchase order / contract for Third Party Website Hosting Services in the amount of \$2,504 for a new not-to-exceed amount of \$70,289 to BS&A Software, Bath, Michigan.

### **REASON FOR PURCHASE:**

The initial award for the website hosting of the City's website (www.rochesterhills.org) was approved by City Council in December 2017 for a three year term. The City's website provides information from the Assessing, Treasury and Building Departments to our customers via the Permit's & Property Data Lookup page. One of the benefits of the website hosting is the ability for the Building Department to allow online permit applications. The cost to the City is \$2.00 per application; however, due to COVID-19, the City had experience more online permits this year than anticipated and an increase requires City Council approval.

The additional funds being requested in order to maintain services for the remainder of the contract set to expire on December 30, 2020.
