TAP, MUNICIPAL WATER AND SANITARY SEWER CONNECTIONS, AND TO REPEAL CONFLICTING OR INCONSISTENT ORDINANCES.

#### THE CITY OF ROCHESTER HILLS ORDAINS:

<u>Section 1</u>. Section 54-46 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

#### Sec. 54-46. Roadside stands, markets, and Christmas tree sales.

The fees for operating roadside stands, markets, and Christmas tree sales shall be as follows:

The fees for services and acts performed by the building department, including, but not by way of limitation, the issuance of building permits, examination of plans and specifications, inspection of construction undertaken pursuant to a building permit, issuance of certificates of use and occupancy, issuance of permits for demolition of and moving of buildings, charges for work started before a permit is obtained, special investigations, reinspections, etc., shall be paid as set forth in this article.

<u>Section 3</u>. Section 54-154 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

  - (1) R-3 and U plan review shall be computed at 0.00147 of the estimated construction cost or \$75.00, minimum. This fee covers two reviews: the initial review and one re-review. A fee of \$75.00 per hour will be charged for additional reviews.
  - (2) All others shall be computed as follows:
    - a. Zero dollars to \$1,250,000.00 shall be computed at 0.00222 of the estimated construction cost or \$150.00 minimum.
    - b. Over \$1,250,000.00 shall be computed at 0.00074 of the estimated construction cost plus the first \$1,250,000.00 at 0.00222.

This fee covers two reviews: the initial review and one re-review. A fee of \$75.00 per hour will be charged for additional reviews.

- (b) For Review of site plans associated with planning commission activities, an escrow balance of \$150.00 shall be established and maintained, which shall be used to pay applicable fees shall be charged at \$75.00 per hour.
- (c) Where review of construction documents is performed by city employees other than building department employees, the review fee shall be charged at \$75.00 per hour.
- (d) Plan review of hazardous materials shall be charged at \$75.00 per hour.
- (e) Plan review for accessibility, energy, structural, mechanical, plumbing, electrical, and fire protection shall be charged at 15% of the building plan review fee or \$150.00 minimum. This fee covers two reviews: the initial review and one re-review. A fee of \$75.00 per hour will be charged for additional reviews.

- (f) Payment shall be in advance of the review based on estimated cost.
- Where review of construction documents is performed by outside consultants, the review (g) fee shall be charged at 1.5 times the actual cost. Payment shall be in advance of the review based on estimated cost.
- (h) High hazard occupancies (group H) will be charged an additional 25% of the calculated plan review fee.
