COUNCIL AND YOUTH COMMITTEE REPORTS

Rochester Hills Government Youth Council (RHGYC):

President Deel introduced **Maya lyer**, Rochester Hills Government Youth Council (RHGYC) Representative.

Ms. Iyer stated she is a senior at Rochester High School. She shared that this is her fourth year on the RHGYC and currently serves as the RHGYC Representative on the Citizens Pathway Committee and the Diversity, Equity and Inclusion Board. She announced that in the month of December the Youth Council has painted and dropped off 85 ornaments to the Rainbow Connection and they are sponsoring three (3) families for the New Day Foundation's Hope for the Holiday Program. She stated the RHGYC is currently in the process of planning their projects for January.

Joe Snyder, Chief Financial Officer, explained that the City received various Grants and Other Revenues in the form of reimbursements in 2020 for things such as election reimbursements, Personal Protection Equipment (PPE), disinfecting and administrative duties due to COVID, Museum operations, Fire Department and Oakland County Sheriff's Office payroll, low-income water and sewerage arrearages, Auburn Corridor, Livernois, Avon Creek, Innovation Hills and other various programs which totaled \$5,272,382.99.

Mr. Snyder presented the 4th Quarter Budget Amendments, noting the following financial highlights for FY 2020:

- Total Revenues are proposed to increase by \$6,900,000 (+5%) due to the various grants and reimbursements

- Total Expenditures are proposed to decrease by \$5,100,000 (-3%), encompassing * \$4,900,000 in Operating Expenditures (-5%)

- * \$3,500,000 in Capital Expenditures (-5/
- 33,500,000 in transfer out experiditures (-8%)

* \$3,300,000 in transfer-out expenditures (+13%) - \$12,188,040 positive impact to Fund Balances City-wide; of this amount,

\$3,300,000 is anticipated to be carried over to FY 2021 for projects not completed.

He mentioned that \$40,449,960 was undertaken in Capital Projects this year, with \$22,877,800 from Fund Balance. He noted that the \$17.6 million difference represents the City's structural surplus for the year.

He explained that approximately 31 percent (\$12.3 million) of the City's Capital Outlay was in water and sewer projects as the City begins to update the aging water and sewer system that was installed approximately fifty (50) years ago. Some of those projects included Bedford Square Apartments, the Tienken Road Court watermain, Glidewell Subdivision and the northeast pump station improvements through the Oakland-Macomb Interceptor District.

He broke down the remaining Capital Outlay for FY 2020, as follows:

-Facilities projects (\$10 million) included the Dairy Barn roof and truss replacement, work at Innovation Hills, Auburn Road Corridor Plaza, as well as the Museum Equipment Barn.

-Local Streets (\$6.8 million) including \$5 million local street asphalt and concrete programs, as well as the SAD paving of Michelson and Bolinger. -Major Roads (\$5.7 million) includes major roadway work along Auburn Road Corridor, John R from Avon to Bloomer, Harding Rd. and Austin Ave. -Fleet (\$2 million) purchased 12 vehicles and eight (8) pieces of equipment. -Fire Capital (\$1.7 million) purchased two (2) Fire Engines along with the Fire Radio replacement program.

-Pathways (\$500,000.00) covers pathway on Crooks Road from Clinton River to Avon Road.

Mr. Snyder summed it up by announcing that approximately two-thirds of the City's Capital Outlay (\$27 million) was in projects delivered by the Department of Public Services in 2020. He noted that \$40 million is a record for Capital Outlay in a single year, and stressed that these projects were done with no debt being issued.

In 2021 \$30 million worth of Capital Projects are currently budgeted. The administration is anticipating another big year for infrastructure reinvestment and quality of life improvements.

He noted the following regarding the City's individual funds:

- General Fund - Revenues are anticipated to be up by \$1.2 million. Much of this is due to the CARES Act Funds and State Shared Revenue coming in better than anticipated. Corresponding expenditures are expected to balance out at also \$1.2 million higher. There is a decrease in operating expenditures of \$909,000, and an increase of \$2.1 million in transfers out contributed to the Capital Improvement Fund. No change in Fund Balance is anticipated. General Fund is kept at 70 to 80 percent of general operating expenses. Any overage is transferred to the Capital Improvement Fund.

- Capital Improvement Fund - Revenues are anticipated to be \$3.0 million higher due to the transfer-in from the General Fund. Expenditures are anticipated to be \$55,000 lower as less funding is needed for Capital Projects. Fund Balance for the Capital Improvement Fund is anticipated to be \$3.1 million higher, increasing the overall Capital Improvement Fund Fund Balance by \$1.5 million; for a total in the Fund Balance of \$11.4 million at year's end.

- Major Road Fund - Revenues are anticipated to be \$744,000 higher; Expenditures are anticipated to be \$885,000 lower, and the Major Road Fund Fund Balance is anticipated to be \$1.6 million higher. \$500,000 is anticipated to be carried over

to FY 2021. He pointed out that only \$1 million was needed from Fund Balance to accomplish \$5.8 million worth of projects.

- Local Street Fund - Revenues are anticipated to be \$335,000 lower; Expenditures are anticipated to be \$430,000 lower. No need for funding from Fund Balance. Over \$40 million has been expended over the past seven years in improving Local Street infrastructure.

- Fire Department - Revenues are anticipated to be \$446,000 higher; Expenditures are anticipated to be \$446,000 higher, consisting of a decrease of \$422,000 in operating expenditures and an increase of \$869,000 in transfers-out to the Fire Capital Fund.

- Fire Capital Fund - Revenues are anticipated to be \$959,000 higher due to the transfer-in from the Fire Operating Fund; Expenditures are anticipated to be \$544,000 lower. \$617,000 is anticipated to be carried over to FY 2021 to complete some capital projects. Fund Balance is anticipated to be \$1.5 million higher, for an anticipated balance of \$12.6 million.

- Special Police - Revenues are anticipated to be \$625,000 higher; Expenditures are anticipated to be \$208,000 lower; with a net positive change to Fund Balance. He noted that the plan had been to draw down the Special Police Fund Balance to get closer to the 25 percent of annual operations in Fund Balance; however, the CARES Act funding contributed to the Fund Balance. He mentioned that over the next several years the Special Police Fund Balance will be brought down to the 25 percent target.

Mr. Snyder listed the projects to be carried over to 2021 by fund, and noted that they would be included in the 1st Quarter Budget Amendment in February 2021.

He summarized that 2020 has been one of the most challenging years the world has ever seen; however, it has also been one of the most unexpectedly best financial years the City has ever seen. Long-term strategic planning will keep the City operating with a structural surplus, with surpluses directed to the City's Capital needs. He thanked City Council for their support.

Council Discussion:

Ms. Mungioli thanked Mr. Snyder for his presentation and expressed her appreciation to all of the City staff for the work they have done this past year.

Vice-President Bowyer congratulated City staff and the Fiscal Team on capturing the \$3.29 million in CARES funding for reimbursement.

Mr. Hetrick acknowledged Mr. Snyder's work toward maintaining a consistent favorable budget variance.

Mayor Barnett stated this 4th Quarter Budget Amendment reflects how well the City's finances are being managed. He reflected over the past year on the COVID pandemic and all of the uncertainty that came along with it. He congratulated Mr. Snyder and the entire City Team on the work they have done in pursuing grants,

public and private partnerships, as well as seeking reimbursement under the CARES Act funding. He celebrated the financial success the City has experienced during a year that presented so many tremendous financial challenges.

President Deel stated that he is appreciative of how hard the City Team works each year to ensure that the City's financial stability continues. He noted that it has never been more evident than this past year.

Joe Snyder, Chief Financial Officer, and **Ron Jewell**, Rochester Avon Recreation Authority (RARA) Executive Director, presented RARA's 4th Quarter Budget Amendments.

Mr. Snyder stated that RARA's budget amendments propose a decrease in total revenues of \$1.1 million and a decrease in total expenditures of \$900,000.00; resulting in a net revenue of \$1.643 million and expenditures of \$1.685 million. The net impact to RARA's Fund Balance for FY 2020 is a negative \$41,000, representing approximately two percent of RARA's annual expenditures. He noted that RARA came into 2020 with \$365,000 in Fund Balance, which was 14.5 percent of FY 2019 operating expenditures. He pointed out that due to the significant decrease in 2020 operating expenses, RARA's FY 2020 Fund Balance is projected to be 19.3 percent, very close to the 20 percent operation goal.

Mr. Snyder explained that at the beginning of 2020, RARA was positioned to have a very successful year. He noted, however, that the COVID pandemic utterly crippled RARA's programming this year. He commended Mr. Jewell and his team on the difficult decisions that had to be made relative to staffing, as well as the creative ways in which they offered programming. He stated that RARA has recently received approval for reimbursement in the amount of \$176,000 under the CARES Act funding, and pointed out that this reimbursement is not included in the proposed Revenue totals for the FY2020 4th Quarter Budget Amendment. He concluded that with the additional CARES Act funds, RARA's Fund Balance is projected to be approximately \$500,000 at the end of 2020, or 30 percent of 2020 operating expenditures.

Mr. Snyder stated that looking forward the RARA Board has approved a conservative revenue and expenditure balanced budget over the next three years, taking into account the lingering impact of COVID moving forward for some time to come.

Mr. Jewell thanked the entire RARA staff on a job well done. He noted that despite the challenges in 2020, they were laser focused on offering excellent programs safely. He stated that RARA will continue to evolve in 2021 as the communities premier recreation provider.

Kristen Kapelanski, Planning Manager, stated that the applicant is requesting the property at 1021 Harding be delisted from the City's Historic Districts. She explained that the property is approximately two (2) acres and was designated Historic by the City in 1978. She mentioned that the property suffered an extensive fire approximately three years ago and the applicant has stated that the expense to repair it would far exceed the value of the property after the repairs effectively rendering it unsalvageable. She pointed out that the Building Department had inspected the house on the property and had expressed concern relative to its safety.

Ms. Kapelanski referenced Chapter 118, Historical Preservation, of the City's Code of Ordinances which identifies the process for the establishment, modification or elimination of historic districts. She pointed out that the ordinance establishes that the Historic District Study Committee (HDSC) review such requests and make recommendations to City Council. She explained that the ordinance also requires that the initial request be made to the City Council. She stated that if City Council chooses, the next step is for them to refer this request to the HDSC for review. She outlined the process and stated that it generally takes six months to complete. She stated the applicant, Paul Miller, and a representative from the realtor's office were available to answer any questions.

Council Discussion:

President Deel introduced **Kim Widiker** who stated she was filling in for the realtor, as she could not attend the meeting. Ms. Widiker mentioned that she is Mr. Miller's ex-wife, as well as an appraiser and the owner of two (2) homes listed on the National Historic Registry.

Ms. Widiker explained that Mr. Miller requested that she speak on his behalf. She commented that this is a very difficult situation as Mr. Miller and his family have owned this home for decades and were very proud to have a historic home. She noted that Mr. Miller has been a member of the Historic Districts Commission (HDC) and has dealt with the Historic Districts in both Rochester Hills and Oakland Township. She commented that it is has been very difficult for Mr. Miller to request that this property be delisted. She stated that although they are aware that the process can take up to six months, they are requesting that City Council request the HDSC to move forward with this request as soon as possible. She commented that although the City, the neighbors and the community have been very understanding and helpful, they are being encouraged to address this issue. She explained that although it has been three years since the fire took place, Mr. Miller had been caring for his 101-year old mother who recently passed. She noted they understand the house needs to be taken care of and requested that the HDSC review it so that they can make a recommendation to Council.

President Deel stated that he recalled when the fire occurred and noted that it was a terrible event.

Mr. Hetrick noted that the request being made to the HDSC is to work as swiftly as possible to study and resolve this matter. He stated that he had previously been by the exterior of the home; however, after reviewing the photographs that have been provided of the interior, he does not believe the house is salvageable.

- Completed construction of the City's first Splash Pad.

- Council passed resolutions in support of local businesses allowing for outdoor dining/seating and temporary signs. Council Members also personally financed the purchase of gift cards for the Rochester Hills Restaurant BINGO to support local restaurants.

- Safety measures put in place to protect the public and employees at City Hall, including providing Personal Protection Equipment (PPE).

- The Rochester Hills Government Youth Council (RHGYC) delivered cards to

the residents of some local senior facilities. They also provided ornaments and supported several families through the New Day Foundation and Rainbow Connection.

Ms. Mungioli shared resources available for addressing mental health concerns. She stated there are options available, some at no or low cost. She stressed the importance of talking about and addressing mental health and encouraged anyone in need to reach out and ask for help. She announced that she will post additional resources on her Council Facebook page.

Vice-President Bowyer listed all of the various parks, trails and nature areas where residents can get out and walk. She encouraged everyone to continue to wear their masks, practice social distancing and consider getting the vaccine once it is available. She wished everyone a Happy Holiday Season.

Mr. Hetrick wished everyone Happy Holidays.

Mayor Barnett stated he is proud of the entire City staff, Directors, the Fire Department and Oakland County Sheriff's Office for the work they did over this past year. He pointed out that they were challenged with finding ways to offer service in a safe and efficient manner and went above and beyond to do so. He provided the following updates:

- The new City website was launched last week.

- He was one of five mayors, five governors and leaders of some key organizations such as FedEx, UPS, Walgreens and CVS invited by President Trump to participate in the Vaccine Summit last week to talk about the vaccine distribution. He noted that Governor Whitmer has directed the number of vaccines requested and where they are to be delivered. In Rochester Hills those vaccines will go first to long-term healthcare facilities and then to first responders by the end of December 2020 or first week in January 2021.
