## Langeron Charities, Inc. Attachment to Amendment (March 25, 2015)

## ARTICLE II

The purposes for which the corporation is organized are charitable, religious and educational purposes within the meaning of Section 501(3)(c) of the United States Internal Revenue Code of 1986, as amended, (hereinafter, the "IRC") and not for pecuniary profit or financial gain. Langeron Charities, Inc. is organized exclusively for charitable, religiou, educational and scientific purposes, including, for such purposes, the making of contributions to organizations that qualify as exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3 of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of Langeron Charities, Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Further, the purposes of the corporation are: To bring to life a culture and traditions of Langeron Charities

- a) Recreational activities of a Langeron Charities.
- b) All events for generating funds, focus around different types of recreational activates which might require local permits, but all events for generating funds are be allocated for charitable purposes, including but not limited to childhood, housing and clotting needs.
- c) Schedule and handle charitable fund raising events for funds to be used for the benefits of the community.
- d) To be a part of the community that welcomes people of all backgrounds.
- e) To represent the interests of Langeron Charities funds needs in government and public organizations.

The following activities may be conducted during the event: bingo, amusement games, and contests of chance, lotteries, and raffles

In furtherance of the foregoing purposes, the corporation shall have the power to solicit grants and contributions and the power to maintain a find or funds of real or personal property.
