SUBJECT:	Rouge District Sanitary Sewer Rehabilitation Project Rouge River Grant Agreement City File No. E12-005

REQUEST:

The City of Rochester Hills has received a grant through the Rouge River National Wet Weather Demonstration Project (Round XI) to perform a sanitary sewer rehabilitation project in the southwest portion of the City. The total project cost is \$90,600. The City is responsible for 60% of the approved cost (\$54,360) and Wayne County will reimburse the City \$36,240 from the grant. The Department of Public Services recommends accepting the terms of the attached grant with Wayne County and authorizes the Mayor to execute the agreement on behalf of the City.

REASON FOR PURCHASE:

The sanitary sewer system in the southwest corner of the City of Rochester Hills is located in the Rouge River Main 1-2 sub-watershed. In 2010 Rochester Hills obtained a Round X Part A grant from the Rouge River National Wet Weather Demonstration project to undertake an inflow and infiltration study for this area. The study was completed in 2011 and the report identified needed rehabilitation work. This Round XI grant provides the City funding to implement the sewer rehabilitation work in the City's Rouge District as identified in the Round X Final Report. The rehabilitation work will help prevent sanitary sewer overflows (SSO's) to the Rouge River and sewer backups into basements.

The City will prepare contract documents in the spring of 2013 and bid out the sanitary sewer rehabilitation project with construction commencing in the summer of 2013.
