SUBJECT: Purchase Authorization for Backflow Hose Bibbs

REQUEST:

City Council is requested to authorize a blanket purchase order for backflow hose bibbs to Progressive Plumbing Supply in the amount of \$96,000.00 through May 30, 2025.

REASON FOR PURCHASE:

Invitations to Bid were solicited to over 300 vendors utilizing the MITN system. Three (3) responses were received with Progressive Plumbing Supply submitting the low bid.

The decision to supply backflow hose bibbs was made to minimize the overall time and costs of the Cross Connection Program. Many homes were being failed during the cross connection inspections because their outdoor spigots were not fitting with backflow preventing hose bibbs. It was determined that the cost of purchasing and providing hose bibbs would be offset by the need for re-inspections. Further, homeowners were spared the inconvenience of having to go purchase hose bibbs themselves and schedule re-inspections.

Some residential homes have more than one outside spigot therefore the supply is being utilized at a faster rate than what was initially estimated. Award is recommended to Progressive Plumbing Supply as the low responsible bidder.
