SUBJECT: Bathroom Partition Replacement

REOUEST:

City Council is requested to authorize the purchase for bathroom partition replacement at the Bloomer Park Pine Grove & Hilltop Restrooms to Allied Building Services Company of Detroit, Inc. of Detroit, MI, in the amount of \$24,386.28, plus a 10% contingency of \$2,438.63 for a not to exceed total of \$26,824.91.

REASON FOR PURCHASE:

The bathroom partitions at Bloomer Park Pine Grove & Hilltop Shelters are worn out and in need of replacement. By completing this upgrade it will also bring the restrooms into ADA compliance.

The Purchasing Division solicited competitive sealed Request for Proposals for the bathroom partition replacement including sections for demolition and installation. A site visit was held to give potential proposers access to the site. Three competitive proposals were received. A committee comprising of staff from Facilities and Purchasing evaluated the responses and determined the response from Allied Building Services Company of Detroit, Inc. was most advantageous for the project.

The proposal received from Allied Building Services Company of Detroit, Inc. was deemed to be the best value to the City based on their proposed methodology to perform and complete the work and providing the lowest cost to perform the work and is recommended for award. The vendor has performed similar services for the City satisfactorily in the past.
