SUBJECT: Renewal of Google Apps Hosted Email Services

REQUEST:

It is requested that City Council authorize a blanket purchase order for a one year renewal of hosted Google Apps email services and BetterCloud management application to Onix Networking Corporation, Lakewood, OH in the amount not-to-exceed \$50,000.00 through August 30, 2020.

REASON FOR PURCHASE:

The City moved to a hosted Google Apps email platform in September of 2010. The service has been working well and the City makes use of many of the additional services included in the Google Apps package. This purchase is a yearly renewal.

The City is unable to obtain better pricing than what Onix Networking Corporation is currently offering the City. Purchasing reached out to several Google App Partners to try and obtain pricing and was informed that based on our SIMBA approval on our account that no other vendor is able to provide us lower pricing that what we currently receive through Onix Networking Corporation. SIMBA is a discount that is provided by Google and is only valid if the City's current partner uses it. We can receive additional quotes but they would be higher and most partners I reached out to would not provide pricing because they stated they could not be competitive. The Purchasing Division has reached out to Google to see if there is additional ways in the future to still obtain the discounted pricing and seek competition but has not received a response to the inquiry yet. Based on the City's need to renew the licenses it is recommended that award be made to Onix Networking Corporation as the lowest cost available to the City. The Purchasing Division will continue to research this to see if there is anything that can be done; however it is unlikely as this is a method than many of the larger technology firms utilize. HP and Dell have a setup that is very similar to Google.
