SUBJECT: Increase to Blanket Purchase Order for Fire Suppression and Fire Alarm Plan Review and

Inspection Services

REQUEST:

City Council is requested to authorize an increase to the contract/blanket purchase order for Fire Suppression and Fire Alarm Plan Review and Inspection Services to Fire Safety Consultants, Inc., Elgin, Illinois in the amount of \$68,000.00 for a new not-to-exceed contract amount of \$318,000.00 through a new contract end date of December 31, 2022.

REASON FOR PURCHASE:

The City of Rochester Hills solicited proposals from qualified and experienced firms to assist the Building Department with fire suppression and fire alarm plan review and inspection services for commercial and industrial projects in accordance with the State of Michigan Construction Codes utilizing the MITN system. Three proposal responses were received. A committee consisting of staff from the Building Department reviewed the proposals and recommended award of the contract to Fire Safety Consultants, Inc., Elgin, Illinois based on their qualifications and experience, capacity to perform the work, ability to meet City turnaround requirements and overall best value cost proposal, receiving City Council approval of the award recommendation at the August 10, 2020 meeting.

The request for the addition of funds and extension of the contract end date is to allow the City time to finalize the solicitation process for these services. With approval of the additional funds, and contract extension this shall provide sufficient time to complete our process.

The City has been doing an increased number of plan review and inspections services for fire suppression and fire alarms, but is comfortable with the increase request and timeframe. The plan review and inspection fees are reimbursed to the City by commercial and industrial developers and is a pass-through cost.

Fire Suppression and Fire Alarm Plan Review and Inspection Services costs incurred by the City are charged back to commercial and industrial developers in the form of a pass-through charges which reimburse the City / General Fund for costs incurred.

If approved by City Council, 4th Quarter 2022 Budget Amendments shall be presented to increase the General Fund / Building Department's Professional Services line-item for the additional Fire Suppression and Fire Alarm Plan Review and Inspection Services costs with an offsetting increase the respective General Fund / Revenue accounts to offset the impact on the General Fund.
