SUBJECT: Auburn Road Corridor Reconstruction Project - Street Lighting - DTE Street Light Agreement

REQUEST:

The Department of Public Services requests City Council to approve the Master Agreement for Municipal Street Lighting (Agreement) between the City of Rochester Hills and the Detroit Edison Company for the installation of street lighting on the north and south side of the proposed reconstructed area of Auburn Road between Culberston Avenue and Dequindre Road. The Department of Public Services requests City Council authorize the Mayor to execute the Agreement on behalf of the City and to authorize the payment identified in the Agreement, in the amount of \$359,156.35.

REASON FOR PURCHASE:

This lighting is being installed as part of the Auburn Road Corridor Reconstruction Project. The lighting in the five (5) intersections and two (2) roundabouts in the proposed reconstructed area will consist of eighteen (18) single 133w LED Autobahns on eighteen (18) single posts with frangible bases. The material for all eighteen (18) lights are of Special Order Material (SOM) Code 06 with a custom paint finish (Metal-Polyester Powdercoat Finish-Titanium) with the color to match pedestrian lights below.

On both sides of Auburn Road thirty two (32) 115w LED Alcott Series post/luminaire Special Order pedestrian lights will be installed. The post/luminaire is a one piece assembly that is factory pre-wired on 14' posts.

The Purchase Agreement for the construction costs for this lighting, including labor, materials, and overhead was submitted by DTE on February 8, 2019 in the amount of \$359,156.35. The City of Rochester Hills is responsible for 100% of the funding for the project at this time, though outside resources are currently being investigated.
