AN ORDINANCE TO AMEND CHAPTER 138, ZONING, OF THE CODE OF ORDINANCES OF THE CITY OF ROCHESTER HILLS, OAKLAND COUNTY, MICHIGAN, TO REZONE ONE PARCEL OF LAND TOTALING APPROXIMATELY .91 ACRE, KNOWN AS PARCEL NO. 15-29-427-036 LOCATED at 2642-2652 CROOKS ROAD WEST OF CROOKS, SOUTH OF M-59 FROM B-4 (FREEWAY SERVICE BUSINESS) TO REC-W (REGIONAL EMPLOYMENT CENTER, WORKPLACE) AND TO PRESCRIBE PENALTIES FOR THE VIOLATION THEREOF.
