**SUBJECT:** Building Alarm & Monitoring Services

#### **REQUEST:**

City Council is requested to authorize a blanket purchase order/contract for building alarm and monitoring services in the amount not-to-exceed \$30,000.00 for a one-year term to expire June 30, 2020 to Weber Security Group, Inc. of Mt. Clemens, Michigan.

### **REASON FOR PURCHASE:**

The City requires the need for a qualified and licensed firm to perform building alarm and monitoring services at various City-owned buildings including the parks and museum.

The City issued a solicitation for the services utilizing the MITN system. Five proposals were received and were evaluated by a committee consisting of staff from Communications, Facilities, and Purchasing. The recommended vendor providing the best value was from Weber Security Group, Inc. of Mt. Clemens, Michigan. The contract term is one year with four one-year renewals. The third renewal expires June 30, 2019, and Weber Security Group, Inc. has agreed to hold pricing for the fourth and final available renewal year.

Weber Security Group, Inc. is recommended for award of the building alarm and monitoring services for one year based on their satisfactory performance in accordance with the terms and conditions of the contract with pricing determined to be low, fair and reasonable.
