**SUBJECT:** On-Call Executive Search Firm Services

#### **REQUEST:**

City Council is requested to authorize a blanket purchase order for on-call executive search firm services in the not-to-exceed amount of \$75,000 through April 30, 2024 and further authorizes the Mayor to execute a contract on behalf of the City.

### **REASON FOR PURCHASE:**

Five years ago the City, in anticipation of retirements that would soon be occurring, determined there was a need to engage the services of an executive search firm to assist with recruitment and selection of various City management and executive level positions. It was felt an executive search firm could supplement City staff and provide additional local, regional, and national resources that would benefit the City in attracting and recruiting talented and well-qualified candidates. The City has determined that the utilization of this process has assisted the City well, and has provided an excellent resource in the recruitment of many of the City's executive level positions that have been filled over the past five (5) years due to retirement. The City feels the continuation of having this contract in place to address future needs is of great benefit.

The City issued a Request for Proposal utilizing the MITN system. Eight (8) proposal responses were received and evaluated by a committee consisting of staff from Human Resources, Fiscal, and the Mayor's Office. The committee shortlisted to two (2) firms and subsequently conducted interviews with both firms. Based on the proposal review and interviews, the committee determined GovHR USA, LLC provides the best value to the City based on their experience and qualifications, project team assigned to the City, past work experience, projects with the City, outreach efforts, resources, and other services that can be offered to assist the City with executive level position recruitment, coaching, position needs assessments, and other resources to successfully fill positions with qualified individuals. Award is recommended to GovHR USA, LLC. The City has been utilizing their services for the past five (5) years and has been satisfied with the services received.
