SUBJECT: Shoulder Right-of-Way, detention basin,

site distance/shoulder mowing (Part B – Department of Public Services)

REQUEST:

City Council is requested to authorize a blanket purchase order to Kleen Kut of Gilbertsville, Kentucky for shoulder right-of-way, detention basin and site distance mowing services in the not-to-exceed amount of \$152,250.000 through December 31, 2013.

REASON FOR PURCHASE:

Request for Proposals were solicited and evaluated by DPS/Engineering staff based on best value to the City in terms of quality of service, experience and capacity of contractor and cost proposal. The proposals included Part A responding to the Building Department needs and Part B for the Department of Public Services.

The Department of Public Services utilizes the expertise and specialized equipment of a lawn maintenance and weed mowing contractor for boulevards, shoulders and detention basins mowing, as well as to maintain adequate site distances along roadways. Kleen Kut has provided additional value-added services to the City, including additional cuts, photographs and excellent follow-up when damages occur. The continued utilization of Kleen Kut to perform these services will maintain the standard of quality and service levels expected from the contractor, without increasing the management staff time for oversight and contract administration. Proposals from lower priced contractors with less experience and equipment will not provide a good value for the City.
