SUBJECT: Firewood & Falcon Drive Rehabilitation and Firewood Pathway Construction
City File No. E13-003

REQUEST:

The Department of Public Services requests that City Council approve Amendment No. 1 with Spalding DeDecker Associates, Inc. (SDA) for engineering design services for the Firewood and Falcon Road Rehabilitation and Firewood Pathway Construction Project in the amount of \$19,724.00 for a total not-to-exceed amount of \$123,288.00 and authorizes the Mayor to execute a contract on behalf of the City.

REASON FOR PURCHASE:

Firewood and Falcon Drive are scheduled for roadway rehabilitation and pathway construction this year. The original scope of services for engineering design services was approved by City Council on January 14, 2013 in the amount of \$103,564.00.

Since the Falcon/Coachwood Ln. pavement is in poor condition, it was decided that the pavement should be replaced with this project and reconfigured to a modern roundabout. SDA will design the proposed roundabout which will include layout, plans, grades, signing and pavement marking, and a traffic plan during construction. The proposed roundabout design budget will be \$15,730.00.

After discussions with the adjacent homeowner's associations, it was decided to include an additional segment of pathway along the east side of Firewood from north Stonetree Cr south to the existing open space playground area should be constructed. The proposed budget to include the additional stretch of pathway segment is \$3,994.00.
