SUBJECT: Software for Water Quality Monitoring and Sampling Selection

REQUEST:

City Council is requested to authorize a blanket purchase order/contract software for water quality monitoring and sampling selection to Aquasight, Troy, Michigan as the software service provider and Great Lakes Water Authority (GLWA), Detroit, Michigan as the payee in the amount of \$27,533.25 for a three year period to expire on January 31, 2022.

REASON FOR PURCHASE:

Great Lakes Water Authority (GLWA) awarded a contract to Aquasight LLC that provides a software analytical tool, which uses water-sampling data and a water distribution systems hydraulic model to calculate the age of the water in water distribution systems. The City will receive benefit from utilizing this software analytical tool because it will provide insight into the age of water in our distribution system, which will allow for better operation and maintenance management of the water distribution system. Purchasing has reviewed and researched the information provided and has determined that Aquasight is a single source provider in that the City, if they were to solicit for this tool on their own, would not benefit from doing so because they would not receive the timely results of water sampling data that GLWA currently collects in addition to the standardized analysis to GLWA customers. There is a benefit to the City to enter into this agreement. GLWA established pricing for the benefit of participating agencies if they utilized the agreement and GLWA has secured a Competitive Grant Assistance Program (CGAP) award that will pickup the on-boarding fees estimated at \$5,000. The City will contract with Aquasight for the software tool and will remit payment to GLWA for this service.
