Subject: Review of Second Reimbursement Request, Legacy Rochester Hills, LRH Development LLC,

Northeast Corner of Hamlin and Adams Roads, Rochester Hills (ASTI Project No. 9675-21)

As requested by the City of Rochester Hills (the City), ASTI has reviewed all provided documentation regarding a reimbursement request from LRH Development, LLC (the Developer) for the project located at the northeast corner of Hamlin and Adams Roads. The project includes two parcels, 15-29-101-022 (Parcel A) and 15-29-101-023 (Parcel B), which are considered the Eligible Property. The following documents provided the basis for this review:

- 1. The Brownfield Plan dated April 9, 2018
- 2. The Reimbursement Agreement, dated April 23, 2018
- 3. The Reimbursement Request prepared by AKT Peerless, dated July 22, 2019 (the Request)

The purpose of this review is to determine if the Request for the Eligible Property is in compliance with the approved Brownfield Plan, the Reimbursement Agreement, 1996 PA 381 (Act 381) at the time of the Brownfield Plan approval, the City's cost reimbursement procedures, and generally accepted practices. The following are specific requirements for a request for reimbursement:

- The Reimbursement Agreement requires that the applicant submit copies of invoices and an itemized statement of costs, including a narrative of work completed.
- The Brownfield Incentives Policy for the City only indicates that a reimbursement request include invoices and proof of payment organized by category.

This review includes the attached Table 1, which summarizes the Request by category and Table 2, which summarized amounts recommended for reimbursement to date, and provides our understanding of the status of each task.

Background

The Eligible Property is the subject of a Brownfield Plan approved on April 23, 2018 (the Plan), a Reimbursement Agreement approved April 23, 2018, and a 381 Work Plan dated June 14, 2018. The Plan estimates that eligible costs with contingency to be \$9,619,587, and that interest will be an additional \$3,800,000, for a total estimated not-to-exceed reimbursement of \$13,419,587. The Plan estimates that tax increment capture will continue for 21 years, but will not exceed 24 years.

Reimbursement Request

This is the second reimbursement request for this project. This Request is for \$3,618,107.54 for eligible activities as described in the request. However, two errors were noted in the request that change the amount requested as indicated below and in Table 1.

- Invoice No. 415546 (reference line 71 in Table 1) was listed in the Request for \$1,522.00 but was actually for \$1,522.50.
- Invoice No. 418395 (reference line 72 in Table 1) was listed in the Request for \$6,789.00 but was actually for \$6,786.00.

Therefore, this review is based on a requested amount of \$3,618,105.04.

The documentation provided included descriptions of completed work and the total expenses. ASTI has reviewed the request and allocated the work performed to the appropriate eligible activity category from the Brownfield Plan. These changes are unsubstantial and include the following:

- Health and Safety Plan was moved from BEA to HASP;
- Brownfield Plan, Act 381 Work Plan and Cost Tracking & Compliance activities were separated based on the description provided, and'
- Dewatering, Temporary Site Control, Installation of Liner and Cap, NFA Due Care, and Closeout Reporting activities were separated out of the generic Due Care Activities.

The Request included copies of all invoices being requested for reimbursement, and an Accounts Receivable Ledger from AKT Peerless. A detailed narrative was not provided. As indicated in Table 1, the information provided was insufficient in some instances, and therefore, some expenses were noted as Potentially Eligible but needing additional information or documentation. In specific, this included.

- 1. Reference Lines 71 to 80: The invoices include partial deletions of the descriptions for work performed, assumed to be for ineligible work, but charge the full level of effort. Additional information as to why a credit was not provided for the ineligible portion of the work is requested.
- Reference Lines 88 to 131: Invoices did not include the geographic location for the activities to distinguish if activities were completed on Parcel A or Parcel B. Additional clarification on the parcel location for each activity is requested.
- 3. Reference Lines 153 and 154: AKT submitted invoices for oversight of encapsulation activities, presumably on Parcel B, but it is our understanding that installation of liner and cap over the former landfill had not occurred as of February 28, 2019. This expense is likely oversight of the design of the liner and cap. ASTI made this assumption for the first reimbursement request, but is now requesting additional information.

The following costs are considered ineligible as described below:

- 1. Reference Lines 73, 74, 75, 76, 77, 79 and 80: These invoices include ineligible activities such as review of the reimbursement agreement and negotiations with the City.
- 2. Reference Lines 71 to 80: Act 381 limits reimbursement for Brownfield Plan and 381 Work Plan preparations to a total of \$30,000. Over \$30,000 was approved for these tasks under the first

reimbursement agreement. Therefore, otherwise eligible costs included in these invoices are considered ineligible.

Conclusion


The Accounts Receivable Ledger for AKT indicates payments for the attached invoices, but individual invoices are not marked as paid, cancelled checks were not provided, there is no statement that invoices were paid, and a waiver of lien or AIA Application and Certification document was not provided. These expenses are otherwise eligible, but sufficient proof of payment is at the discretion of the RHBRA, and should be referred to the City's legal counsel.

As with the previous request for reimbursement, this Request is for LRH Development, LLC (identified in the Reimbursement Agreement), however, the document provided indicates that the expenses were paid by the Goldberg Companies, or Goldberg (identified in the Plan). Some invoices were submitted to GCI Construction, LLC. All three entities are located at the same address, so this review assumes that they are related entities. Any issues related to the eligible taxpayer should be referred to the City's legal counsel.

Based on the documents provided, the items that have been recommended for approval for reimbursement in the Request are in compliance with the approved Brownfield Plan, the Reimbursement Agreement, 1996 PA 381 (Act 381) at the time of the Brownfield Plan approval, the City's cost reimbursement procedures, and generally accepted practices. In addition, the total amount requested to date is within the approved not-to-exceed amount. Table 2 summarizes the requests for reimbursement to date in comparison to the expenses approved within the Brownfield Plan. Please note that some line items are over budget, which, except as noted above, was not a consideration in recommending approval for reimbursement. RHBRA has the authority to approve expenses in amounts that vary from the amounts listed in the Brownfield Plan. The following is a summary of our recommendations for this Request.
