**SUBJECT:** Parks Roof Replacement Project

# **REQUEST:**

City Council is requested to authorize a contract/blanket purchase order for City Park Roof Replacements at the following locations: Avondale Park, Bloomer Park, Borden Park, Van Hoosen Jones Museum Farmhouse/Red House/Gazebo, and Spencer Park to Garland/DBS, Inc., Cleveland, Ohio in the amount of \$1,796,650.00 with a 10% project contingency in the amount of \$179,665.00 for a total not-to-exceed project amount of \$1,976,315.00 and further authorizes the Mayor to execute an agreement on behalf of the City.

# **REASON FOR PURCHASE:**

The City completed a roof assessment project in 2020 in which each City building's roof was assessed to determine its condition and to create a plan to repair and/or replace the roof structure along with a timeline for replacement to be completed. The first phase of this project is to replace the Parks roofs which conditions have deteriorated to the point that they need to be replaced as repairs are no longer an option based on the roof's condition.

The City determined that it was best to engage the services of Garland/DBS, Inc., to assist with the project. Garland is a construction management firm that strictly specializes in roofs. We are utilizing these services as part of the OMNIA Partners National Cooperative Contract Program. Garland/DBS, Inc. was awarded the National Roofing Supplies and Services contract from a competitive solicitation process lead by Racine County, Wisconsin. The contract provides for specifications development, solicitation of competitive bids, and construction management services. The competitive bids for replacement of the roofs were solicited by Garland/DBS, Inc., in coordination with the City. This roofing project will include for the installation of Cedar Shake Roofs at the Museum campus due to the historical nature of the site, along with Standing Seam Metal Roofs and Shake Asphalt Shingles at the other locations. The low bid for the roofing project was Schena Roofing and includes a 30-year warranty on the metal roofs provided by Garland and a 5-year workmanship warranty for the Cedar Shake roof provided by the Contractor.

Garland/DBS, Inc., has performed similar services for the City in the past and the City has been very satisfied with the services provided. Award is recommended to Garland/DBS, Inc., as the best value to the City.

#### **BUDGET:**

Partial Funding is included in the FY 2022 [\$550,000] and FY 2023 [\$1,000,000] Adopted Budgets, for a grand total of \$1,550,000 currently budgeted between the two (2) Fiscal Years for the project.

The newly established Parks Infrastructure Millage Fund still has approx. \$250,000 of funding generated in FY 2022 which has not yet been allocated for FY 2022 Parks Infrastructure projects. It is recommended to utilize that remaining \$250,000 of Parks Infrastructure Millage funding, to be transferred-out to the Facilities Fund to contribute to the Parks Roof Replacement project. If approved by City Council, a FY 2022 4<sup>th</sup> Quarter Budget Amendment will be presented to transfer \$250,000 from the Parks Infrastructure Millage Fund to the Facilities Fund for the project.

The Facilities Division, Parks Department, and Finance Department will all be monitoring the project and any use of the proposed \$179,665 in project contingency. If any additional funds are required for the project due to the use of project contingency, that additional funding can be contributed by the Capital Improvement Fund via a transfer to the Facilities Fund for the project. If additional funding is needed for contingency, those funds will most likely be presented a FY 2023 Quarterly Budget Amendment as the project nears completion.
