SUBJECT: 2018 Asphalt Road Rehabilitation Program – Tienken Road Center Left Turn Lane

Design & Construction Engineering Services, City File No. E18-002

REQUEST:

The City Council is requested to approve a design & construction engineering services contract with Spalding DeDecker for the proposed 2018 Asphalt Road Rehabilitation Program – Tienken Road Center Left Turn Lane in a not-to-exceed amount of \$34,800.00.

REASON FOR PURCHASE:

The Department of Public Services in partnership with the Rochester Community Schools is desirous of constructing a continuous center left turn lane from Adams High School to Olympia Drive through the previously approved 2018 Asphalt Road Rehabilitation Program. Based on the 2018 department workload, the Department of Public Services has determined an engineering consultant should oversee the design & construction engineering services.

Staff recommends Spalding DeDecker to provide the design & construction engineering services to the City. The attached proposal describes the scope of services included for the construction engineering services to complete the work.
