SUBJECT: Reconstruction/Repair Fire Station #1 Solids Interceptor and Fire Station #2 Oil Interceptor

REQUEST:

It is requested that City Council authorize a contract/blanket purchase order for construction management services for the reconstruction and repair of Fire Station #1 Solids Interceptor and Fire Station #2 Oil Interceptor in the amount not-to-exceed \$47,530.59 to the George W. Auch Company, Pontiac, Michigan and authorize the Mayor to execute a contract on behalf of the City.

REASON FOR PURCHASE:

The interceptor/drain at Fire Station 1 has corroded to the point that it will no longer hold the weight of a fire truck and needs to be replaced. The interceptor/drain, located in the apparatus bay area, takes water from the trucks and washing operations in the apparatus bay to the City sewer system. This interceptor was originally installed when the station was built in 1989.

The original interceptor/drain at Fire Station 2 ran into a French drain that was installed when the station was built in 1969. This French drain is no longer functioning and does not meet current City standards. The installation of a new drain pipe and connection to the City sewer system is being proposed.

The City, utilizing Oakland County's Cooperative Purchasing Program, contracted with the George W. Auch Company to provide as needed construction management services to assist the City with some of the larger capital projects it had budgeted for the current year due to their complexity and services needed. Oakland County issued a Request for Proposal in which they issued and awarded an as-needed construction management services contract with The George. W. Auch Company and extended it to other MITN agency members.

The George W. Auch Company worked in coordination with the City's Architect, H2A and the City to determine the scope of work that needed to be completed to reconstruct and repair Fire Station #1 Solids Interceptor and Fire Station #2 Oil Interceptor and subsequently in coordination with the City's Purchasing Division issued an Invitation To Bid for this project. Recommendations to the City for approval of the awards of the trade contracts based upon review of each lowest, responsive, responsible bid was provided and reviewed by the City's Purchasing Division. The George W. Auch Company, interviewed each lowest, responsive, responsible bidder to determine the contractor's qualifications and ability to meet schedule requirements and has recommended award of the trade contract to the lowest, responsive, responsible bidder with the City's Purchasing Division's concurrence.

BUDGET:

If approved by City Council, a 3rd Quarter Budget Amendment will be forthcoming. The additional funding is recommended to be drawn from excess funds budgeted for FA-02K: Fire Station #1 Rear Access Drive Reconstruction, which came in approx. \$182,800 under budget, so no additional funding is requested from Retained Earnings.
