SUBJECT: Construction Management Services – Pre-Construction Services and Preparation of GMP

REQUEST:

City Council is requested to authorize a blanket purchase order/contract for Construction Management Services to perform pre-construction services and preparation of guaranteed maximum price for Fire Station #4 to George W. Auch Company, Pontiac, Michigan in the amount not-to-exceed \$27,460.00 and further authorizes the Mayor to execute a contract on behalf of the City.

REASON FOR PURCHASE:

The City, with the approval of the Architectural/Engineering Services Contract to Sidock Architects is beginning the design development phase of Fire Station #4. During this phase of the contract the City's Architect is working in coordination with the City's Construction management firm, George W. Auch Company, to continue preparing probable project cost estimates, ensuring budget projections are maintained, and constructability of the design is obtainable. When the design phase of the project has been completed, George W. Auch will bid the project in coordination with the Purchasing Division, and coordinate with Sidock Architects on pre-bid meetings, issuance of proper addendums in response to the bid request, evaluate substitution requests, etc. After the bid process is completed and reviewed, approval of award for Fire Station #4 Construction Management Contract with a guaranteed maximum price will be presented to City Council for approval, along with Phase III (Construction/Contract Administration Assistance) for architectural/engineering services for the construction of the station.

The City issued Request for Proposals for Construction Management Services last year, which were inclusive of services for all fire stations, including Fire Station #4. City Council issued award to the George W. Auch Company at its October 15, 2015 meeting for all stations, except Station #4. The request before you now is to approve Construction Management Services for the Design Development and Preparation of the Guaranteed Maximum Price portion of this project in the amount of \$27,460.00. The City has been exceptionally pleased with the services George W. Auch has provided in managing the current, ongoing fire station projects. They have proven to be a strong team member for the City, a great partner, and have managed the project budget and been fiscally responsible with the contingency allowances.
