City Council is requested to authorize a blanket purchase order/contract for Construction Engineering Services for the Kayak Landing Project at Innovation Hills in the not-to-exceed amount of \$25,560.00 to Hubbell, Roth & Clark, Inc., Bloomfield Hills, Michigan and further authorizes the Mayor to execute the contract on behalf of the City.

REASON FOR PURCHASE:

Hubbell, Roth & Clark Inc. is one of the City's selected engineering firms that was conducted through a Request for Proposals process. HRC is qualified and the most experienced engineering firm to perform the services needed for this project based on their background with the Innovation Hills project and are able to provide the professional efforts required for the needed engineering services for the construction engineering services needed for this project.

The construction of the kayak landing was competitively bid and award recommended to WCI Contractors, Inc. Contingent upon approval of award to WCI Contractors, Inc., City Council is requested to authorize a blanket purchase order/contract for construction engineering service to Hubbell, Roth & Clark, Inc.
