### **REQUEST:**

The Department of Public Services recommends awarding the contract for the *Tienken Manor North and Grosse Pines Water Main Replacement Project* to Bidigare Contractors, Inc. of Plymouth, Michigan in the amount of \$5,140,365.00.

The Department of Public Services also requests City Council authorization of a 10% project contingency in the amount of \$514,036.50 for a total not-to-exceed construction cost of \$5,654,401.50 and further authorizes the Mayor to execute a contract on behalf of the City.

#### **REASON FOR PURCHASE:**

The Tienken Manor North and Grosse Pines water main replacement project is being completed because of its age and material type. The Scope of Work includes the replacement of approximately 25,400 LFT of 6-inch and 8-inch cast iron and asbestos cement (AC) water main with 10-inch & 12-inch high density polyethylene pipe (HDPE) SDR 11 pipe via the pre-chlorinated pipe bursting method.

Rochester Hills received three (3) sealed bids for the project on March 30, 2021 (bid summary attached). Of the bids received, Bidigare Contractors, Inc. was the lowest, responsive, responsible bidder.

Work is expected to begin in May 2021 with a completion dated scheduled for November 2021.

Funding is included in the FY 2021 Adopted Budget.

If adopted by City Council, a 2<sup>nd</sup> Quarter Budget Amendment will be done to move \$922,110 from WS-57: Grosse Pines Subdivision Water Main Replacement, which came in under budget, to WS-08 Tienken Manor Subdivision Water Main Replacement, which came in over budget. The budget amendment will have no impact on Retained Earnings.
