REQUEST:

The Department of Public Services (DPS) requests that City Council authorize a blanket purchase order/contract for construction engineering services for the Eastern Avenue Parking Lots South of Auburn Road project to OHM Advisors in a not-to-exceed amount of \$82,000.00 and further authorizes the Mayor to execute a contract on behalf of the City.

REASON FOR PURCHASE:

The City recently received bids for the proposed Eastern Avenue Parking Lots South of Auburn Road project. Based on the current DPS workload, the Department has determined that an engineering consultant should perform the construction engineering services.

DPS recommends that OHM Advisors be used to provide the construction engineering services to the City. The attached proposal includes the scope of services and corresponding estimated costs for OHM Advisors to provide the construction engineering services work.
