### **REQUEST:**

City Council is requested to authorize a contract/blanket purchase order for preliminary engineering (PE) services for the Hamlin Road Reconstruction Project from Crooks to Adams to Nowak & Fraus Engineers, Pontiac, Michigan in the amount not-to-exceed \$289,552.00

### **REASON FOR PURCHASE:**

The Hamlin Road (Adams to Crooks) project is in the approved Capital Improvement Plan (CIP) and the project funding is identified in both City Council approved 2020 & 2021 budgets. To prepare for the reconstruction in 2021, the next step is to proceed with the Preliminary Engineering (PE) of the project. The scope of services for the PE phase will prepare the engineering construction plans & specifications for bidding the project.

Nowak & Fraus Engineers (NFE) is one of the City's on-call professional engineering firms and is recommended to be utilized for these services on this project. The attached proposal was requested from NFE to perform the necessary work to create engineering design documents for future (January 2021) bidding of the reconstruction of Hamlin Road.
