REQUEST:

City Council is requested to authorize a contract/blanket purchase order for preliminary engineering (PE) services for the Waterview Drive road reconstruction project to Hubbell, Roth & Clark, Inc. (HRC), Bloomfield Hills, Michigan in a not-to-exceed amount of \$186,400.00.

REASON FOR PURCHASE:

The Waterview Drive road reconstruction project is in the approved Capital Improvement Plan (CIP) and the project funding is identified in existing and future City budgets. This road reconstruction is within the Local Development Finance Authority (LDFA) district and has been previously authorized by the LDFA Board as a priority project. The scope proposes to reconstruct the entire roadway of Waterview from Auburn to Leach and to construct a new sidewalk on one side of Waterview Drive and also along the west side Leach from Waterview to the existing Adams Road pathway.

HRC is one of the City's on-call professional engineering firms and is recommended to be utilized for this project. The attached proposal was requested from HRC to perform the necessary work to create engineering design documents for bidding the reconstruction of Waterview Drive in 2022. A project location drawing for Waterview Drive is also enclosed for reference.
