SUBJECT: MDOT Contract for Livernois Road between Avon and just north of Walton

REQUEST:

The Department of Public Services requests that City Council approve the contract with the Michigan Department of Transportation for the Livernois Road rehabilitation project from Avon Road to just north of Walton Boulevard and appoint the Mayor, Bryan K. Barnett, to be the authorized representative to sign the contract on behalf of Rochester Hills.

REASON FOR PURCHASE:

State Senator Marty Knollenberg helped secure a funding appropriation for Rochester Hills from the Community Infrastructure Investment program for roadway rehabilitation of Livernois Road from Avon Road to just north of Walton Boulevard. A total of up to \$700,000.00 was allocated for Rochester Hills to use towards its project expenses for the roadway rehabilitation project. Funding is administered through the Michigan Department of Transportation (MDOT) and the attached contract with MDOT requires that a City representative be assigned to sign the contract on behalf of Rochester Hills.
